Full redemption of Non-Convertible Debentures - ISIN INE852F07079 (Scrip code - 958709)

We would like to inform you that the Company has completed full redemption of Non-Convertible Debentures (NCDs) of Series A1- ISIN INE852F07079 (Scrip cdode-958709), by making payment of Rs.115 crores towards redemption amount of 1150 NCDs of face value Rs. 10 lakhs each and Rs. 3.19 crores towards interest on the aforesaid redeemed debentures (1150 NCDs), aggregating to Rs. 118.19 crores, today.

The Company had originally issued 2,500 Debentures under Series A1 - INE852F07079 (Scrip code - 958709) amounting to Rs. 250 crs.with scheduled redemption date of 7 April 2021. In January, May and June 2020, the company had partially redeemed 500, 600 and 250 debentures of Series A1 amounting to Rs. 50 crores, Rs. 60 crores and Rs. 25 crores respectively. With this redemption of today, Series A1 debentures stands fully redeemed.
