Textual Information(1)	The Honble National Company Law Tribunal, Mumbai bench, vide its Order dated 2nd December, 2021 approved the Companys petition for a composite scheme of amalgamation under Sections 230 to 232 read with other applicable provisions of the Companies Act 2013, involving amalgamation of subsidiary company - Gateway East India Private Limited with Gateway Distriparks Limited ("GDL") and post the aforesaid amalgamation, Gateway Distriparks Limited would amalgamate into subsidiary company - Gateway Rail Freight Limited ("GRFL"). 2021.The scheme has become effective from December 28, 2021.On the Effective Date, the Company shall stand dissolved without being wound up as envisaged in Scheme. Further, pursuant to the Scheme, all the shareholders holding shares in GDL as on the Record Date i.e., January 06, 2022, will be allotted shares in GRFL in the ratio of 4:1, i.e., 4 Equity Shares of GRFL will be allotted against 1 Equity Share held in GDL.The Transferee Company, GRFL has initiated the process of filing the Information Memorandum with SEBI and will be applying for listing of its securities
